



**Warning:** Do not depend on any switch as sole means of disconnecting power when installing or servicing the fan. If the power disconnect is out-of-sight, lock it in the open position and tag to prevent application of power. Failure to do so may result in fatal electrical shock.

- Follow all local electrical and safety codes in the United States and Canada, as well as the National Electrical Code (NEC) and the Occupational Safety and Health Act (OSHA) in the United States, and the Canadian Electric Code (CEC) in Canada.
- 2. Motor must be properly grounded by wiring with a grounded, metalclad raceway system, by using a separate ground wire connected to the bare metal of the motor frame, or other suitable means.
- Always disconnect power source before working on or near a motor
  or its connected load. If the power disconnect point is out-of-sight,
  lock it in the open position and tag to prevent unexpected application
  of power.

**Caution**: In United States, to reduce the risk of injury to persons, OSHA complying guards are required when fan is installed within 8 feet of floor, ground, or working level.

**Caution**: In Canada to reduce, the risk of injury to persons, CSA complying guards are required when fan is installed below 2.5 meters (8.2 feet) above floor or grade level.

Warning: Motor will restart without warning after protector trips.

Caution: Do not touch motor. It may be hot enough to cause injury.

- 4. Be careful when touching the exterior of an operating motor. It may be hot enough to be painful or cause injury. With modern motors, this condition is normal if operated at rated load and voltage; modern motors are built to operate at higher temperatures.
- 5. Protect the power cable from coming in contact with sharp objects.
- 6. Do not kink power cable and never allow the cable to come in contact with oil, grease, hot surfaces, or chemicals
- Make certain that the power source conforms to the requirements of your equipment.


## **Description**

Venturi-mounted exhaust fans are used for commercial, industrial, and farm building ventilation. Wire intake guard complies with United States OSHA Federal 1/2" max. opening requirement and has baked-on charcoal grey metallic polyester finish to resist corrosion. All units are supplied with aluminum propeller with a galvalume coated spider. Fans are powered by a 115V, 60 Hz., totally enclosed motor (split phase or shaded pole) designed for service where air contains high concentration of dust, dirt, grease, moisture, etc. Shipped completely assembled. Optional Accessories: Speed Controller for up to 3 amps, Part No. 5ACCO3SC and 3 to 6 amps, Part No. 5ACCO6SC.

## **Unpacking**

- 1. Inspect carefully for any damage that may have occurred during transit.
- 2. Before installing, rotate the propeller to be sure there are no obstructions which would interfere with proper operation. Adjust as required.



### Installation

1. The unit should be securely mounted in a rigid framework.



Allowing the fan frame to flex or move will result in undue vibrations and possible premature motor or propeller failure.


- 2. Connect power to motor, using an approved wiring method.
- 3. Install any auxiliary components.



The fan motor must be securely and adequately grounded to a suitable electrical ground such as a grounded water pipe or ground wire system!

4. Before activating the fan, double-check to ensure that there are no obstructions (framing, stud, shutter, etc.) which would interfere with proper fan operation.

#### Single Speed




Figure 2 - Wiring Diagrams

## **Operation**

- 1. For proper air circulation, keep the area free of objects that could impede air flow on either the intake side or exhaust side of fan.
- 2. The unit is now ready for operation. All units can be operated continuously.

### **Maintenance**



Do not depend on any switch as sole means of disconnecting power when installing or servicing the fan. If the power disconnect is out-of-sight, lock it in the open position and tag to prevent application of power. Failure to do so may result in fatal electrical shock.

#### Minor and routine

- 1. Lubricate the motor sleeve bearings every six months using S.A.E. 20 non-detergent oil.
- 2. Periodically clean the propeller and motor of any excessive accumulation of dirt.

#### **Parts and replacement**

- 1. Refer to Figure 3 for correct positioning of parts.
- 2. Refer to "Repair Parts List" for ordering information.

- 3. Disconnect power before servicing.
- 4. Remove the four screws and nuts holding the guard to the venturi panel. Remove the guard/motor/propeller assembly.
- 5. Loosen the setscrew on propeller hub and remove the propeller.



Do not repair damaged propellers. They should be replaced with a properly balanced replacement.

- 6. Loosen the nuts holding motor on guard and remove motor. On split phase models, it is also necessary to loosen and remove bolt and nut holding yoke brace to motor yoke tabs.
- 7. Reassemble the unit in reverse order of disassembly.




Figure 4: Repair parts illustration
